TERMS AND CONDITIONS

- It is the responsibility of the parent/guardian to ensure that the child is equipped with all the necessities before registering in the crèche (i.e. nappies, bottles, drinks, dummies). Prams or bassinets must also be provided for those babies under 1 yrs for safety reasons.
- The maximum amount of time a child is to be left at Crèche is 90 minutes per child allowing plenty of time for a workout and shower.
- Children will not be admitted if they are over 6 yrs
- Children will not be admitted if they are deemed sick or have a contagious condition. This is at the discretion of the Crèche Attendant on duty.
- Admission of any child into the crèche is at the discretion of C Life attendant on duty
- The crèche is strictly reserved for the use of C Life full members only and only for the period of time that the parent is exercising in the Health Club.
- If a child requires parental/guardian comfort or discipline, they will be notified immediately and asked to attend to the situation.
- Please note if there are any changes to your personal details or your Child's medical condition, you must complete another enrolment form with updated information included. Please sign below that you agree to abide by the above.
- In the event of an emergency, children will evacuate with trained crèche staff to the evacuation point. Parents/Guardians can evacuate with the crèche staff and their child, and they must sign off that they have removed their child/ren as per normal operating policy at the evacuation point.
- Please ensure your child has been fed prior to your booking. Food is not permitted into the crèche for health and safety reasons.
- Please refrain from bringing toys into crèche to avoid arguments between children. This includes electronic toys (i.e. DS and mobile phones). We provide a range of toys and play equipment that is upgraded on a regular basis.
- **Special Needs**
- While we welcome all children we do not have the staff resources to cater for children with additional needs therefore the assistance of an adult carer, supplied by the parent, who can stay with the child for the duration of the booking will be required.
